## **MIXING AND APPLICATION:**

- Shake well before use.
- Mix the required quantity of **DIURON 800 SC** in a small quantity of water to make a smooth cream. Add this to the half filled spray tank and top up with water.
- Keep the chemical in continuous suspension in the spray tank by means of proper agitation.
- Apply in 200 – 400 litres water per hectare using flat fan type or flood jet nozzles.
- Accurately calibrate spray equipment prior to application.
