APPLICATION GUIDELINES

CYFLO® acts as a pentrant and must preferably not be used in conjunction with other noncompatible or contrasting penetrants. Add CYFLO® in spray water buffered to a suitable pH prior to addition of crop nutrients or crop protection remedies. Note that CYFLO® is not a wetting agent and does not enhance the spreading of spray solutions on foliage. CYFLO® should preferably be applied with WETTA (L8337) or SILICOTE (L9079) as wetting agents if wetting and spreading is required.
